1. What Are Cookies

1.1 Cookies are small text files placed on your device when you visit a website. They help sites work, remember your preferences, keep you signed in, and understand how the site is used. This Cookie Policy explains how **Lacspace Corporation Pvt. Ltd.** and its products use cookies and similar technologies, and how you can control them. It supplements our [Privacy Policy](#).

2. How We Use Cookies

- **To operate** the Services — sign-in, security, and core functionality.
- **To remember** your settings and preferences.
- **To measure** performance and understand usage so we can improve.
- **To personalise** content and, where you consent, marketing.

3. Consent & Your Choices

3.1 Strictly necessary cookies are always active because the Services cannot function without them. For non-essential cookies (analytics, personalisation, and advertising), we ask for your consent where required by law, and you can change your choices at any time through your browser or our cookie controls.

Withdrawing consent does not affect processing that already took place.

4. Categories of Cookies We Use

4.1 We group cookies into the following categories:

- **Strictly necessary** — sign-in, session, security, load-balancing, and core features. Always on.
- **Functional** — remember preferences such as language, theme, and layout. Optional.
- **Analytics / performance** — understand usage, measure performance, and improve the Services. Consent where required.
- **Personalisation** — tailor content and recommendations to you. Consent where required.
- **Advertising / marketing** — measure campaigns and, where used, show relevant ads. Consent required.

5. First-Party vs Third-Party Cookies

5.1 **First-party cookies** are set by Lacspace domains. **Third-party cookies** are set by providers we use (for example, analytics, payment, or media embeds). Third-party cookies are governed by the providers' own policies; we use reputable providers and limit third-party cookies to what is needed.

6. Similar Technologies

6.1 We may also use similar technologies such as pixels and web beacons (to measure engagement), local storage (to cache preferences and improve performance), and software development kits (SDKs) in our mobile apps. Where relevant, these are treated like cookies for consent purposes.

7. Managing Cookies in Your Browser

7.1 Most browsers let you view, block, and delete cookies through their settings. Blocking strictly necessary cookies may break parts of the Services. Browser help pages explain how to manage cookies for Chrome, Safari, Firefox, Edge, and others.

8. Our Cookie Consent Controls

8.1 Where required, we present a consent banner or preference centre when you first visit, letting you accept or reject non-essential categories and change your choices later. Your preferences are stored so we can honour them on future visits.

9. Do Not Track & Global Privacy Control

9.1 Some browsers send "Do Not Track" or Global Privacy Control (GPC) signals. Where legally required, we honour recognised opt-out signals for advertising cookies. Because there is no single industry standard for these signals, behaviour may vary by region and browser.

10. Opting Out of Advertising Cookies

10.1 In addition to our controls, you can opt out of many advertising cookies through industry tools offered by advertising associations in your region. Opting out does not remove all ads; it limits personalised ones.

11. Mobile Apps & Device Identifiers

11.1 Our mobile apps may use device identifiers and SDKs for analytics, security, and push notifications. You can manage these through your device settings (for example, resetting or limiting your advertising identifier and controlling notification permissions).

12. Changes to This Policy

12.1 We may update this Cookie Policy to reflect changes in technology, the cookies we use, or the law. Material changes will be signalled by updating the effective date and, where appropriate, by re-requesting consent.
